

Artist Streaming Agreement

The Studio Radio · Fimination Ltd (King Fimi)

This Agreement sets out the terms on which you (the "Artist") allow Fimination Ltd, trading as King Fimi and operating The Studio Radio (the "Station"), to broadcast your music. It is intended to be simple, fair, and protective of both parties. Please read it, then complete and sign at the bottom (or submit the online form at kingfimi.com/radio-agreement).

1. What You're Granting

You grant the Station a **non-exclusive, royalty-free, revocable licence** to stream, broadcast, and publicly perform the sound recording(s) you submit (the "Track(s)") on The Studio Radio and its associated online players. Non-exclusive means you remain free to license your music to anyone else, release it, and use it however you wish — this Agreement takes none of that away.

2. You Keep Everything You Own

You retain **all ownership, copyright, and rights** in your Track(s), including the master recording and the underlying composition. This Agreement is only permission to play your music on the Station — it is not a transfer or sale of any rights.

3. No Payment

This is a promotional arrangement. No fee is paid by either party. The Station plays your music to support and expose independent artists; you allow it in exchange for that exposure. Neither party owes the other any royalty, streaming fee, or payment under this Agreement.

4. Credit & Promotion

The Station will credit you by your artist name when your Track plays, and may display a short bio and links you provide (social media, SoundCloud, Apple Music, Spotify) to help listeners find you. You confirm the bio and links you provide are accurate and that you're happy for them to be shown publicly.

5. Your Confirmations

By signing, you confirm that:

- You own or control all rights in the Track(s), or have permission from those who do to grant this licence;
- The Track(s) do not infringe anyone else's copyright or other rights;
- The Track(s) contain no unlicensed samples that would prevent this broadcast;
- You have the authority to enter into this Agreement.

6. Ending the Agreement

You may withdraw your permission at any time by emailing studio@kingfimi.com. On receiving your request, the Station will stop broadcasting your Track(s) and remove them from rotation within a reasonable period. The Station may likewise stop playing any Track at its discretion. Nothing here obliges the Station to broadcast your music for any minimum period.

7. Liability

You agree that if a third party brings a claim against the Station because the Track(s) you submitted infringed their rights, that is your responsibility, not the Station's — since only you know the true rights position of your music. Neither party is liable to the other for indirect or consequential losses. Nothing in this Agreement limits any liability that cannot be limited by law.

8. Governing Law

This Agreement is governed by the laws of Scotland and subject to the jurisdiction of the Scottish courts.
